## Information Flyer

For candidates seeking registration as a Licensed Practical Nurse (LPN) for British Columbia College of Nurses and Midwives (BCCNM) or as a Registered Practical Nurse (RPN) for the College of Nurses of Ontario (CNO)



### The Eight Steps of the REX-PN<sup>®</sup>

1. Contact BCCNM/CNO to review and fulfill the REX-PN registration and application requirements.
2. Register and pay the exam fee online or by calling Pearson VUE Candidate Services.
  - Payment via credit, debit or prepaid card will be accepted.
3. Receive Acknowledgement of Receipt of REX-PN Registration from Pearson VUE by email.
4. BCCNM/CNO makes you eligible to test in your Pearson VUE profile.
  - You must be made eligible by BCCNM/CNO within 365 days of your REX-PN registration and payment.
5. Receive Authorization to Test (ATT) email from Pearson VUE.
  - You must test within the validity dates on the ATT. There are no extensions.
6. Schedule your exam appointment online or by calling Pearson VUE Candidate Services at 866.496.2539. For French support call 866.288.8454.
7. Arrive for the exam appointment with your acceptable identification and complete your exam.
8. Receive your official results from BCCNM/CNO up to six weeks after your exam.

### Rules for Scheduling

If you need to schedule, reschedule or cancel your appointment:

- Tuesday, Wednesday, Thursday or Friday appointments must be changed 24 hours in advance of the original date and time. For example, if your appointment is on Wednesday at 2:00 pm, then you must call or go online to reschedule by Tuesday at 2:00 pm.
- Saturday, Sunday or Monday appointments must be changed no later than the Friday before the original date and time. For example, if your appointment is on Monday at 2:00 pm, then you must call or go online to reschedule by Friday at 2:00 pm.
